Overview

Beginning on, or around, Monday, April 12, 2010 and ending on or around Friday, May 14, 2010 QCountry 103.7 WQNY will play the CanCun Tune of the day contest.

How to Play

WQNY Q-Country 103.7 will play the "Can Cun Tune" of the day

- Weekdays between 7AM and 7:30AM, QCountry 103.7 air personalities will announce the "song of the day" and later that day before 7PM when the "Song of the Day" is played again, caller number 7 at 607-257-9769 and the 7th person to text TUNE to 77000 will qualify as well.
- On May 15, 2010 at The Haunt at 702 Willow Avenue Ithaca all contest qualifiers will be invited to attend a Grand Prize Drawing Event..
- No purchase is necessary to enter any WQNY Q-Country 103.7 FM contest.
- All contestants must be 21 years of age and live in a 75 mile radius of 1751 Hanshaw Road Ithaca NY
- One entry per person will be permitted to participate in Can Cun Tune contest.
- Standard text message rates apply. We are not responsible for any factor affecting the availability or performance of the text messaging service.
- Anytime the WQNY Q-Country 103.7 FM on-air studio is called, it is assumed by the caller that the phone call is being recorded and may be broadcast. The caller grants permission to WQNY Q-Country 103.7 FM to broadcast the call or record the call for later broadcast.
- For telephone contests, listeners may enter by calling 607-257-9769. If any problems are discovered by WQNY Q-Country 103.7 FM, different call-in numbers or addresses may be substituted and utilized after those numbers and addresses are broadcast on WQNY Q-Country 103.7 FM. In the event a caller is disconnected during a contest before his/her name and phone number is recorded, then the prize will be awarded to the next caller whose name and phone number are recorded.
